<b>WHY?</b>	Financial companies choose how they will share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.																									
<b>WHAT?</b>	The types of personal information we collect, and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Social Security and Income</li> <li>• Account Balances and Payment History</li> <li>• Credit History and Credit Scores</li> </ul> When you are no longer our customer, we continue to share your information as described in this notice.																									
<b>HOW?</b>	All financial companies need to share customers' personal information to run their everyday business. In the sections below, we list the reasons financial companies can share their customers' personal information; the reasons Coffee County Bank chooses to share; and whether you can limit this sharing.

<b>What we do</b>	
<b>How does Coffee County Bank protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and buildings.
<b>How does Coffee County Bank collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>- Open an account or deposit money</li> <li>- Pay your bills or apply for a loan</li> <li>- Use your credit or debit card</li> </ul> We also collect your personal information from credit bureaus, affiliates, and other companies.
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>- Sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>- Affiliates from using your information to market to you</li> <li>- Sharing for non-affiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
<b>What happens when I limit sharing for an account I hold jointly with someone else.</b>	Your choices will apply to everyone on your account - unless you tell us otherwise
<b>Definitions</b>	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>- <i>Coffee Financial</i></li> <li>- <i>New Haven Mortgage, Inc.</i></li> </ul>
<b>Non-Affiliates</b>	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>- <i>Coffee County Bank does not share with non-affiliates, so they can market to you</i></li> </ul>
<b>Joint Marketing</b>	A formal agreement between non-affiliates financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>- <i>Coffee County Bank doesn't jointly market</i></li> </ul>
